10TH SANGGUNIANG BAYAN ORDINANCE NO. 11-10-S-2016

"AN ORDINANCE APPROVING THE OFFICIAL SANTA IGNACIA MUNICIPAL HYMN OR AWIT NG SANTA IGNACIA AND REQUIRING ALL SCHOOLS AND MUNICIPAL ACTIVITIES/EVENTS TO SING ABOVE-MENTIONED HYMN"

WHEREAS, the Official Hymn of the Municipality of Santa Ignacia or Awit ng Santa Ignacia was presented in three versions, the Ilokano, Tagalog and English;

WHEREAS, said Awit ng Santa Ignacia was composed and arranged by well known music lovers of Santa Ignacia, namely: Dr. Emiliano F. Dacayanan, Dr. Virgilio L. Baratang with technical support from Mr. Ernesto Lorenzana, Mr. Pedro R. Estrada, Mr. Adolfo P. Follosco and Mr. Romy Guzman;

WHEREAS, the Tagalog version of which will be officially adopted and with the title – "AWIT NG SANTA IGNACIA";

WHEREAS, every Santaguinian (young and old) should know by heart the "AWIT NG SANTA IGNACIA" to show our LOVE, RESPECT and PATRIOTISM to our beloved town;

NOW THEREFORE, on motion of Councilor Amanda B. Antonio Chairman, Committee on Education, duly seconded, agreed by the body in session;

BE IT ORDAINED AS IT IS HEREBY ORDAINED, that:

SECTION I – Title. An Ordinance Approving the Official Santa Ignacia Municipal Hymn or Awit ng Santa Ignacia and requiring all schools and municipal activities/events to sing abovementioned hymn.

SECTION II - Effectivity. This ordinance shall take effect immediately upon the approval.
